#### **QUALIFICATIONS FOR APPROVAL**

**Age Requirements:** Must be 18 years or older. ALL PERSONS OVER THE AGE OF 18 ARE MUST COMPLETE AN APPLICATION AND BE ON THE LEASE.

**Income Requirements:** Gross monthly income must be at least 2 times the monthly rent (combined). Supplemental income of any kind must be supported with appropriate documentation; (i.e. child support, alimony, disability, etc.)

**Rental History:** Must have at least 1 year of verifiable rental history and have fulfilled all previous lease agreements; having no outstanding balances or negative references. A cosigner may be used; however, an application will be run on them as well.

**Credit History:** No evictions or judgments regarding rental history. Must be able to have all utilities transferred into your name. Security deposit is determined by your credit score.

**Criminal Background:** A criminal Background check will be conducted on all occupants over the age of 18. Applications will be rejected for any of the following reasons:

Felony conviction (7 years)

#### **COMMUNITY POLICIES AND STANDARDS**

Occupancy Standards: A maximum of two persons are allowed per bedroom/loft/den

**Pet Policy:** Tenants may only have approved and registered pets and are only allowed 2 pets per unit. Dogs may not be on the prohibited breed list or any mix thereof. Proof of proper vaccination and licensing must be provided upon request. Pet fee of \$200.00 (Two Hundred) is required for each pet. Exotic pets are NOT permitted.

**Vehicles:** Unit may only have vehicles which are properly registered and insured to whom is on the lease. All vehicles must be kept in operating condition at all times. Prior written request and authorization must be obtained for overnight parking of any boat, camper, commercial vehicle, etc. All vehicles must be kept in the driveway/garage and may not block the street or sidewalk at any time. Grass or street parking is prohibited.
