#### **HOA Rules & Regulations:**

6.6 - In addition to weed abatement, Lot owners will police their Limited Common areas for landscape

neatness. Yards with excessive amounts of plant litter, rockscaping not contained in a tidy fashion, lawns with bare areas, landscaping which is suffering from lack of

water, unpruned cacti, trees, or shrubs, overgrown vines or cacti, or dead/ dying plants are all items which are considered to be unkempt and subject to violation notices and fines.

8.3 — Fifteen (15) mph is the speed limit throughout Rainbow Canyon. Reckless driving will not be tolerated. violation notices and fines

5.4 — Pet owners are responsible for their pet's waste and must pick up after their pet, in any Common or Limited Common area. Pet owners who do not

pick up their pet's feces may be fined without warning. Pet owners may not allow their pet's waste to accumulate on their Limited Common area nor shall such

waste be allowed to exude an offensive odor.
