Date of Agreement

You [Client] may cancel this transaction, without any penalty or obligation within three business days from the above dates.

If you cancel, any property traded in, any payments made by you under the contract or sale, and any negotiable instrument executed by you [client] will be returned within ten business days following receipt by the seller of your cancellation notice, and any security interest arising out of the transaction will be cancelled.

If you cancel, you must make available to the seller at your residence in substantially as good condition as when received, any goods delivered to you under this contract or sale; or you may, if you wish, comply with the instructions of the seller regarding the return shipment of the goods at the seller's expense and risk.

If you do make the goods available to the seller and the seller does not pick them up within twenty days of the date of your notice of cancellation, you may retain or dispose of the goods without any further obligation. If you fail to make goods available to the seller, or if you agree to return the goods to the seller and fail to do so, then you remain liable for performance of all obligations under the contract.

I understand that to end my contract I must have all my bills paid current plus pay for all plows done since last billing plus pay the cancellation fee due based on option selected below.
