The Board of Trustees of Jefferson Township, Montgomery County, Ohio met in regular meeting on the 20th day of March 2018 at 7:00 pm at the Township Offices located at One Business Park Drive, Dayton, Ohio with the following members present: **James McGuire ()** Roy Mann () M. WHEREAS, The Jefferson Township Board of Trustees, Fiscal Officer, and employees perform various duties involving Departments and Operations that are funded by restricted funds; and

WHEREAS, the Jefferson Township Board of Trustees are physically responsible for all Township operations, and want to be accurate with where payroll is to be allocated as part of the permanent budget for 2018; and

WHEREAS, the Board of Trustees and Fiscal Office will be required to complete a Payroll Certifications Form, as suggested by the Auditor of the State, which reflects the percentage of time spent working in each department; and

WHEREAS, Resolution No. 18-045 replaces Resolution No. 18-003(16) passed by Trustees on the 2nd day of January 2018 as 18-003 was part f the temporary budget of 2018, and Resolution No. 18-045 makes the allocations part of the permanent budget of 2018:

WHEREAS, this will make the Accounting of Payroll, and Allocation of Payroll Expenses more accurate than in the past.

NOW, THEREFORE, BE IT RESOLVED the Jefferson Township Board of Trustees move to adopt a resolution to follow the Ohio Revised Code 505.24 and HB153, which provides Townships the ability to compensate Trustees, Fiscal Officers, and paid employees from funds, other than the general fund, based on service and attention spent working in / with the other restricted funds and departments these restricted funds support.
