**THE JEFFERSON TOWNSHIP BOARD OF TRUSTEES WILL WORK WITH COMMUNITY ORGANIZATIONS TO
ESTABLISH A COMPLETE COUNT COMMITTEE FOR THE 2020 CENSUS**

The Board of Trustees of Jefferson Township, Montgomery County, Ohio met in a Regular meeting on the 3rd day of September 2019 in a Regular Meeting at 7:00 PM at the Administrative office located at One Business Park Drive, Dayton, Ohio with the following members present: **Roy Mann () M. Michael McLaughlin () James McGuire ()**

WHEREAS, the United States Constitution mandates that a Census be conducted every 10 years in Article 1, Section 2; and

WHEREAS, Jefferson Township will be a part of the 2020 Census count;

WHEREAS, the first Census took place in 1790, and there have been 22 National Censuses taken since, with the next Census scheduled for 2020; and

WHEREAS, the Bureau of the Census in the United States Department of Commerce is responsible for conducting the Census, and the Federal Government is charged with funding the cost of the Census;

WHEREAS, it takes the cooperation and investment of State and Local Governments working in conjunction with the Federal Government to ensure that the Census is fully executed and represents a complete and accurate count of the people within each jurisdiction; and

WHEREAS, the results of the Census are the foundation for many important decisions made by Federal and State Government, including the disbursement of Federal Fund to States based on population;

WHEREAS, a low participation on the completion of the US Census could be a direct result of lost funding received by the Township to support programs for its residents;

WHEREAS, it will take the collaboration of community leaders, faith organizations, non-profit organizations and State and Local Governments to raise the public's awareness of the importance of the Census, and to find ways to support the Census efforts.

NOW, THEREFORE, BE IT RESOLVED, the Jefferson Township Board of Trustees will work with other community organizations to strive to establish a "Complete Count Committee" comprised of community leaders, faith-based, and non-profit organizations, and representatives of Local Government, to ensure that Jefferson Township is properly and fully counted in the 2020 Census.

Trustee Mann moved for the adoption of Resolution No. 19-094.

Trustee McLaughlin seconded the motion.
